# **CITIZEN INPUT**

- Rose Marie Waldrem, Spokane County, WA Spoke on the omission of page 37 on her last report to the board that described fluoride as an additive to vaccines and the link to autism. She also spoke on airborne hydrogen fluorine affluence from Spokane Municipal Waste Incinerator.
- Caroline Pickett, Spokane County, WA Spoke on the violation of U.S. Constitution by the proposal of Resolutions #14-05 and #14-06. She requested the board veto the resolutions.

## **CHAIR REPORT** – Council Member Chuck Hafner

Board Member Lutz reported the Board of Health (BOH) will review the final goals and the process for the health office evaluation in an executive session at today's meeting.

Board Member Norwood and Mayor Freeman have been appointed to an ad-hoc committee for the health officer evaluation. Their duties will be to follow through with decisions made at today's meeting.

Commissioner O'Quinn clarified that today's executive session is for the purpose of the health officer's evaluation and any decisions would be made in open session.

Board Member Baldwin reported that the Governance committee has worked to improve the performance process and address policy issues as a public health board. There are proposals from the committee on the agenda for approval.

Linda Graham, Health Policy Specialist, reported the strategic planning process is projected to have a completed draft in December, which will be presented to the BOH in January. The Strategic Planning Workgroup and Executive Leadership with staff engagement will draft the goals. The first step of staff engagement was to seek input on mission, vision, values and goals. Staff input will be reviewed at a joint Strategic Planning Workgroup/Executive Leadership meeting on October 7. Staff and BOH will be updated throughout the process.

# **LEGISLATIVE REPORT** – Linda Graham, Health Policy Specialist

The BOH reviewed a list of policies under consideration for the BOH legislative agenda and discussed the process to approve the agenda. A draft legislative priorities agenda will be presented at the October 30 BOH meeting with final approval in December. Linda Graham will work with SRHD Executive Leadership to assure their input is considered in the process. Council Member Hafner requested board members review the proposed agenda and be prepared to prioritize the list at the October 30 meeting.

Linda Graham asked board members to note the controversial issues that the board will need to discuss.

Council Member Pace and Council Member Fagan noted the proposal to raise the tobacco and e-cigarette minimum purchase age to 21 as a controversial item. Council Member Pace noted his prioritization of the agenda as follows: 1) mental health and chemical dependency, 2) medical marijuana, and 3) recreational marijuana.

Council Member Fagan recommended the BOH move forwarded cautiously on coal and oil train safety decisions because of ongoing discussions.

Commissioner O'Quinn requested a document that shows how the current proposed legislative priority list is tied to current SRHD work and agency priorities. She also requested more information on legislative priorities that are not tied to current SRHD work and priorities with reasons to why the agency is focused on them.

Council Member Snyder requested information on the mid-level dental health provider and the paid sick leave proposals.

Commissioner O'Quinn requested more information on the paid sick leave and the health in transportation proposals.

Board Member Baldwin stressed the importance of housing issues, such as the rapid rehousing and homeless issues, which relates to multiple public health legislative proposals.

Commissioner O'Quinn noted that public health funding will also be a priority and will need to be protected.

Council Member Hafner asked BOH members to contact the recording secretary or Linda Graham to request more information on any of the proposed legislative agenda items.

# Board of Health Legal Authority – Michelle Fossum

SRHD has responsibility for the health and wellbeing of citizens within its jurisdiction. It is the responsibility of the BOH to enforce the laws set by the State Department of Health (i.e., Clean Indoor Act, food establishment and water recreation regulations). The BOH can enact its own rules and regulations as it has in the past on items such as electronic cigarettes and the needle exchange program if there is no state rule already in passed.

The bylaws give the board the authority to appoint the health officer and approve the appointment of the administrator. The board is responsible for approving the agency budget and fee schedule, issuing

nonbinding recommendations to the community and assuring the health officer is fulfilling the duties set forth in RCW 70.05.
