CHAIR REPORT – Councilmember Chuck Hafner

HEALTH OFFICER REPORT - Joel McCullough, MD, MPH, MS

Opioid Epidemic Update

An opioid fact sheet will be available for the BOH at the December meeting. In 2012, there were 259 million opioid pain prescriptions in the United States. Three out of four users of heroin started using because of the use of prescription pain medications. The prescription pain medication overdose rates have leveled for the last several years, but there has been a dramatic rise in heroin overdoses with overdoses doubling between 2011 and 2013.

Federal level activities include the Department of Health and Human Services (DHHS) requiring all of their healthcare providers undergo training on appropriate opioid prescribing. DHHS will improve access for those addicted by awarding grants to states to increase treatment capacity and determine barriers that keep those addicted from access. DEA sponsored drug take back efforts will continue twice yearly. The Centers for Disease Control (CDC) will vigorously monitor opioid prescriptions and adverse health effects. The federal government has recently engaged 40 healthcare provider groups to train over 500,000 healthcare providers on opioid prescribing. The numbers of providers who prescribe alternatives to methadone treatment and naloxone (that can reverse opioid overdose) will be increased. Healthcare providers will be educated on public health impacts of prescribing opioids.

The Department of Health (DOH) started a prescription drug monitoring program three years ago that allows healthcare providers to monitor patients to determine if opioids are being received from other sources. The Washington State's Agency Medical Directors' Group has developed guidelines for

prescribing opioids. Rules have been adopted in Washington State that mandates how to prescribe for chronic pain placing limits on medications for non-cancerous chronic pain.

The Washington State Response to the Opioid Epidemic draft plan will be available on the BOH website. The four goals of the plan include: 1) prevent opioid misuse and abuse, 2) identify, intervene and link to treatment and support recovery for persons who have opioid use disorder, 3) intervene in opioid overdoses to prevent deaths, 4) use data and information to detect opioid misuse and abuse, monitor morbidity and evaluate interventions.

Locally, efforts include: the Spokane Opioid Task Force that develops pain management guidelines which are consistent throughout the community, the Providence Consistent Care Program which addresses pain medication seeking behaviors in the emergency room and refer those to primary care providers, providers in the community receiving training on opioid prescribing, and the Opioid Treatment Program at the health district with increased client numbers.

There are no guidelines for prescribing cannabis.

LEGISLATIVE UPDATE - Linda Graham, Healthy Policy and Communications Manager

A 2015 legislative session review sheet, requested last meeting, is in the agenda packet. Board members reviewed the 2016 legislative agenda suggestions list developed at the last board meeting.

Councilmember Snyder recommended "wireless communication" under traffic safety be listed as "distracted driving."

Councilmember Snyder asked Commissioner French how the BOH and City of Spokane could assist Spokane County's legislative topic on mental health services and regional support networks. Commissioner French responded he would have Christine Barada, the director of Housing and Community Development, communicate Spokane County's agenda to the BOH and determine opportunities for assistance. Linda Graham will follow up with Christine Barada and incorporate language of support into the board's legislative agenda. Board Member Baldwin recommended including Better Health Together's efforts as well.

Board Member Baldwin recommended stronger emphasis on vaping by having a subset of specific issues related to tobacco, vaping and other inhaled products.
