## ADMINISTRATOR'S REPORT – Ray Byrne, Interim Administrative Officer

- The Health Policy position is being advertised. Board members were encouraged to share the advertisement with qualified applicants.
- The Public Information Officer's last day was May 29, 2019. The position description is being finalized and will be advertised thereafter. (Councilmember Burke departed at 1:10 p.m.)

# HEALTH OFFICER REPORT - Robert Lutz, MD, MPH, Health Officer

- An Opioid Task Force community forum was held at the beginning of the month with several BOH members attending. Next steps are being planned.
- The second Suicide Prevention Task Force planning meeting was held last week. The action plan will be finalized mid-to-late summer. Grants are being sought to assist task force work.
- The Region 10 Health and Human Resources Regional Director, SRHD staff and Commissioner Kuney met to discuss opioid work by the health district.
- The flu season has been declared over.

• There are nine new cases of the measles with six reported in Seattle, two in Tacoma and one in Snohomish. All cases are in adults. Of the nine cases, only one person is reported to have been vaccinated.

# LEGISLATIVE UPDATE - Robert Lutz, MD, MPH, Health Officer

• The Board reviewed a summary of the legislative session. Councilmembers Beggs and Thompson requested SRHD staff collaborate with local organizations to develop a plan for the next legislative session on common topics. Councilmember Thompson volunteered to assist in the coordination of the meetings.
