ADMINISTRATOR'S REPORT - Amelia Clark, Administrative Officer

• The board was provided an overview of the administrative officer's work since starting the position on September 16, 2019.

HEALTH OFFICER REPORT – Robert Lutz, MD, MPH, Health Officer

- There are 24 Hepatitis A cases in Spokane County with cases increasing in August and September. In response, SRHD has activated its Incident Command Center (ICS). There have been 38 clinics with 626 vaccinations. Councilmember Wick requested a Hepatitis A brief for the board to share with its jurisdictions.
- There have been 535 severe pulmonary syndrome cases with seven deaths in the nation due to vaping. There have been seven cases in Washington State. In response, SRHD has activated its ICS.
- The Quality of Life Survey will be completed this month. There have been 2,300 responses from 14,000 surveys sent to the community.
- Jen Hansen reported on the community effort to address domestic violence and the domestic violence documentary that will be presented on September 30.

LEGISLATIVE UPDATE - Amber Lenhart, Health Policy Specialist

The board was introduced to and was provided a report by the new Health Policy Specialist. Commissioner
Kuney requested selection of priorities prior to December. Councilmember Wick requested a BOH legislative
agenda draft by the October board meeting and for the BOH Policy Committee to consider additional
meetings for the committee to complete its work.

COMPTROLLER REPORT – Mike Riley, Comptroller

- The BOH Budget & Finance Committee will meet on October 3 and 10 to review the proposed budget. The board will review the SRHD 2020 proposed budget at the October 31 meeting.
- The BOH Budget & Finance Committee will review the purchasing policy prior to consideration by the board.
- The board was presented the results of the state audit. SRHD received a finding and a management letter.

• The board was presented a report on public health and homelessness by Edie Rice Sauer, Executive Director, Transitions; Angela Chapman, Transitions; Ashley Beck, Research Scientist, SRHD Data Center; and Amber Lenhart, Health Policy Specialist.
