

Contract Amendment: [s]Cube Implementation for Accela Environmental Health-SaaS

June 12, 2025

SITUATION

SRHD Environmental Public Health Division (EPH) is currently upgrading a new Accela Environmental Health-SaaS software with the assistance of [s] Cube Inc., for the installation and implementation.

BACKGROUND

SRHD EPH Division initially purchased and installed Accela Envision Connect software to support day to day operations in February 2015. The software has been in use by SRHD and supported by Accela from 2015 to current. SRHD was notified by Accela in 2021 of the development of an upgraded software, Accela Environmental Health-SaaS, that better supports EPH functions and that they would be sunsetting Accela Envision Connect in approximately 2025 (final date has not been announced). Once the sunsetting of Accela Envision Connect software occurs, future enhancements will stop, and support of the software will be decreased. The implementation and data transfer to the new software was anticipated to take approximately one year. The Board of Health approved \$343,750 from the general fund as part of the 2023 budget for the purchase and implementation of the new software. SRHD chose to wait a year to allow other WA Local Health jurisdictions to purchase and begin use of the new software and provide input to Accela to allow software modifications/enhancements, prior to proceeding. SRHD Finance placed the \$343,750 in a 2024 designated assigned reserve for use when the final contracts were approved. The initial [s]Cube contract was approved March 28, 2024, with a projected implementation date of June, 2025. Due to additional customization and scripting required to meet SRHD EPH Division needs, the final implementation has been delayed at an additional cost.
