# **ADMINISTRATIVE OFFICER'S REPORT** – Alicia M. Thompson, DrPH, LMSW, Administrative Officer

- Forest Burchinal, Information Technology Specialist, Steve Heidal, Building Maintenance Specialist, and the Information Technology staff were recognized for their work at SRHD.
- The SRHD Annual BBQ will be held on September 16 from 11:30 a.m. until 1:30 p.m. Board members were invited to attend.
- Spokane County has requested the agency reduce its budget from \$500,000 to \$1 million dollars. Staff are working to reduce their budgets. Budget reduction scenarios will be presented at the September 25, 2025, board meeting.

- The Administrative Officer has reached out to the Kalispel Tribe, Spokane Tribe, Native Project and the Healing Lodge of the Seven Nations for tribal representation on the board. The board bylaws are being updated to reflect the changes in the law regarding membership.
- The building masonry work will be completed Friday, August 22, 2025.
- The Treatment Services program had a surplus of \$339,550 at the end of June. Beginning September 6, the program will be open on Saturdays and will be strictly for dosing.

## **FINANCIAL REPORT** – *Kim Kramarz, Controller*

- The state audit has been ongoing since May. The accountability audit is now starting. Board members will be invited to the audit exit conference when it is complete.
- Division budget reviews have begun. The board will receive its first review of the proposed 2026 budget and 2026 fee schedule at the September Board meeting.
- As of the end of June, expenses are at 45% and revenue is at 42%. The reserve balance is at 21% with a total of \$18.2 million in reserves.
- The agency has three discretionary funding streams: Local Government Assistance (LGA) at \$2.88 million, Foundational Public Health Services Reinforcing Capacity funds (FPHS RC) \$2.10 million, and the Spokane County contribution \$2.05 million.

## **HEALTH OFFICER REPORT** – Francisco Velázquez, MD, SM, FCAP, Health Officer

- There have been 240,000 cases of the Chikungunya virus globally.
- There has been one diagnosed case of measles in Spokane county and there have been potential exposures to the public between August 12-15, 2025. There have been 1,356 cases in the U.S. with three deaths.
- There have been potentially hundreds of TB exposures at Eastern State Hospital, and the communicable disease program is working to identify exposures.
- There has been one rabid bat identified in Spokane County. Human and animal health advisories are posted on the SRHD.org website.
- Alicia Kreuzter, BSN, RN, Nurse Family Partnership Program Manager, published recently in the Spokane Medical Journal.
- In 2024, there were 253 lead cases identified. The statewide measurement has been reduced which will increase the number of cases expected this year.
