## **RESOLUTION #23-02**

RE: AMENDING RESOLUTION #22-09 TO CORRECT FINAL EXPENDITURE AUTHORITY OF THE 2022 SPOKANE REGIONAL HEALTH DISTRICT GENERAL FUND BUDGET APPROVED AT THE DECEMBER 1, 2022 BOARD OF HEALTH MEETING

WHEREAS an amendment to the 2022 Spokane Regional Health District general fund budget was necessary to reflect changes in revenues and expenditures of funds unknown at the approval of Resolution #21-11, adoption of the 2022 Budget on December 2, 2021, and Resolution #22-03 authorizing a first 2022 general fund budget amendment on June 30, 2022,

WHEREAS Resolution #22-09 authorized a second 2022 general fund budget amendment on December 1, 2022; and

WHEREAS an error on Resolution #22-09 reflected the original budget of \$47,872,911 rather than the first revised budget of \$51,872,911 as stated on Resolution #22-03; and

WHEREAS the amendment amount requested in Resolution #22-09 is correct, the final 2022 SRHD General Fund Budget should reflect \$53,182,411; and

WHEREAS the Board of Health is the governing body of SRHD and must provide approval for SRHD budgets and amendments

NOW, THEREFORE, BE IT RESOLVED that the Board does hereby adopt Resolution #23-02 that corrects the expenditure authority approved by Resolution #22-09 and hereby authorizes and directs Spokane Regional Health District to adopt the correction at the divisional level and rescinds all previously approved budgets and amendments.

BE IT FURTHER RESOLVED by the Board that the provisions of the following correction shall be effective immediately upon signature as of this date.
