HEALTH OFFICER REPORT – Francisco Velázquez, MD, SM, FCAP, Health Officer

- Kelli Hawkins, Public Information Officer, provided an overview of the *Back to Life* Pediatric Vaccine Campaign.
- COVID-19 cases are about half of what was reported two weeks ago.
- There are about 28,000 cases of monkey pox in the United States. Cases have declined over the last several weeks. Spokane County has nine cases and Washington State has 615.
- Most influenza cases in the United States are mainly H3N2.
- Kirsten Duncan, MPH, and Kaely Glaze, MPH, were recognized for their Spokane Medical Society Journal article on syphilis.

• The Board reviewed the draft BOH 2023 legislative agenda. The agenda will be considered at the December 1, 2022, meeting.
