HEALTH OFFICER REPORT – Robert Lutz, MD, MPH, Health Officer

• The CDC has identified there are 695 cases of measles in the U.S. currently. Measles in Washington are subsiding. The outbreak will be considered over if there are no more cases by April 28. (Stratton returned at 1:42pm)

- There have been 460 influenza hospitalizations in Spokane County. There have been 25 influenza deaths this season and 187 in Washington State.
- A Suicide Prevention Strategic Planning event was held last week. Two additional meetings will be held next month to develop plan metrics.
- An Opioid Crisis event will be held on May 7 at Riverside Place. There are 250 registered for the event.
- The Board received a report on the history of HIV/AIDS. The Washington State HIV conference will be held in Spokane next month.
