ADMINISTRATOR'S REPORT – Amelia Clark, Administrative Officer

 BOH manuals have been created to assist members with governance. Binders that include the manual and agenda packet will be placed at member seats each meeting. The manual is also available on the BOH website.

HEALTH OFFICER REPORT - Robert Lutz, MD, MPH, Health Officer

- There has been a downtick in influenza cases. There have been 70 deaths in Washington State.
- There were 22 cases of pertussis in February.
- There are 82,000 infected with COVID-19 in the world with over 2,000 deaths. The mortality rate is 2%, but significant because the disease is novel and worldwide. SRHD's Incident Command Structure (ICS) has been activated for three weeks to focus on community mitigation. The REDI Healthcare Coalition has been completing surveys to determine resources in case of an outbreak in the region. SRHD staff are informing the public on how to prevent the illness, reviewing plans and procedures to address gaps to strengthen response, and surveilling and responding for the disease. Plans and procedures have been followed for the COVID-19, asymptomatic individuals who are at Sacred Heart Medical Hospital.

LEGISLATIVE UPDATE – Amber Lenhart, Health Policy Specialist

- The Healthy Policy Specialist has met with legislators in Olympia sharing public health work in the local community.
- The next cutoff for bills in in the legislature is tomorrow.

COMPTROLLER REPORT – Mike Riley, Comptroller

- The Board reviewed the 2019 actual report and the January monthly financial report. Approximately \$749,000 was placed into reserves from the 2019 budget. The Board will receive monthly financial reports starting this year.
- The Comptroller is developing an approval process for contracts that require BOH approval.

AGENCY REPORTS

 The Board received a report on the determinants of health and upstream work completed by SRHD to address the determinants.
