## **FINANCIAL REPORT** – Kim Kramarz, SRHD Controller

- The budget is on target with agency expenses at 72% and revenue at 76%.
- Through September 2021, the agency has spent \$8.3 million on the COVID-19 response. A portion of emergency reserves were used for the response and will be replenished for 2022.
- The Washington State Auditor statements and reports will be published today and shared with the Board. There were no findings and no management letters. There were a few exit comments related to processes.

## **ADMINISTRATIVE OFFICER'S REPORT** – Amelia Clark, Administrative Officer

- Behavioral health services related to the new legislation on controlled substances will be discussed at the November 9 Spokane Health Advisory Council (SHAC) meeting.
- Recruitment for the Human Resources manager position is underway.
- Check-in and Chat meetings will be held between staff and the Administrative Officer.
- The financial end-of-year process is beginning in Administration.

### **HEALTH OFFICER REPORT** – Francisco Velázquez, MD, SM, FCAP, Health Officer

- The COVID-19 Delta variant is the most prominent variant in Washington and the nation. Cases in the state and Spokane County are declining, but hospitalizations are still high. Cases and hospitalizations in Washington State are primarily in unvaccinated individuals.
- A new Delta variant AY.4.2 is being followed as a variant of concern. There has been one case of the new variant reported in Washington.

## **BOARD MEMBER CHECK IN**

• Board Member Frostad addressed public comment from a parent who received a letter excluding their child from school due to COVID-19 exposure. The letter received by the parent will be reviewed and revised by SRHD staff and general counsel to provide clarity to those receiving the letter in the future. (Board Member Frostad)
