FINANCIAL REPORT - Kim Kramarz, Controller

• The agency has received the full \$1.98 million in funding from Spokane County. Agency expenses are at 75% and revenues are at 77%. Reserves are currently at 26%.

ADMINISTRATIVE OFFICER'S REPORT - Lola Phillips, Deputy Administrative Officer

- The Disease Prevention and Response division is working on respiratory viruses outbreaks in the community. Weekly reports are listed on the SRHD website at SRHD.org/flu.
- The Environmental Public Health division is accepting applications for its Food Advisory Committee. The committee needs food industry, schools, and consumer representation.
- Human Resources hosted the "Thankful for You" event that recognized staff. The program has also updated the employee handbook, leadership guide and open enrollment materials.
- SRHD is working with the Washington State Department of Health until it can determine an appropriate healthcare coalition administration lead.

HEALTH OFFICER REPORT – Francisco Velázquez, MD, SM, FCAP, Health Officer

- There has been a mild increase in COVID-19 cases, which was not unexpected. The longest variant present during the pandemic (Omicron) is milder than other variants. There is no single dominant variant in world currently.
- H3N2 is the most common flu variant currently.
- Monkeypox has decreased in the last couple of months with 650 cases in Washington State and eight cases confirmed in Spokane County.
