FINANCIAL REPORT - Kim Kramarz, Finance Director & Controller

- The audit exit conference was held on Tuesday. The accountability audit will be completed in October with a submission deadline of December 31. The agency received exit comments and one management letter regarding subrecipient monitoring processes.
- Agency staff met on September 7 and 21 with the BOH Budget & Finance Committee to review the proposed 2024 SRHD budget.
- The DOH appropriation funds, third quarter Spokane County contribution and Foundational Public Health Services funds have been received. Revenues are at 63% and expenses at 60%. Unassigned reserves are 24% with total reserves at \$18 million.
- Credit card fees will now be passed to consumers which is reflected in the 2024 proposed fee schedule. Treatment Services outpatient mental health service fees have also been added to the schedule. The Board requested the Treatment Services director to provide a report to the Board on the new services. (Board Member Patterson departed at 1:58 p.m.)
- The Board reviewed the proposed 2024 SRHD budget. The local dollar request to Spokane County is \$2,071 million. The Tuberculosis program has a local dollar request due to an uptick in cases in the county. A resolution requesting \$2,071 million in funding from Spokane County will be brought to the October 26 meeting for consideration.

HEALTH OFFICER REPORT - Francisco Velázquez, MD, SM, FCAP, Health Officer

- The immunization program report was moved to the October 26, 2023 meeting.
- COVID-19 cases are increasing in Spokane County and RSV cases are increasing in the Southeast of the country. There are new vaccinations available for COVID-19, RSV, and influenza.
