# **LEGISLATIVE UPDATE** – Brandon Bannister, Health Policy Specialist

- The Board received an update on Washington State legislative activities.
- The House and Senate could not agree on amendments to Senate Bill 5536, which failed to pass before the end of session. The Governor may call for a special session to work on the bill.

# FINANCIAL REPORT - Kim Kramarz, Finance Director and Controller

- The final revised budget for 2022 was \$53,182,411 with expenditures at \$47,073,836 and revenues of \$48,972,414. This left a surplus of \$1,898,578 due to COVID-19 funding that offsets local dollar projects and an increase in FPHS funding. The Board's emergency fund is \$1.5 million, and the unassigned reserves are set at 20%. A total of \$16,700,365 are in held reserves. The budget was 88% expenses and 92% revenue.
- The projected 2023 budget is \$53,338,000. ARPA funding is incorporated into this year's budget to complete roofing and window projects. The agency is at 20.8% for revenues and expenses are at 20%. The unassigned reserves are 21% with a total reserve at \$17,132,000.

# ADMINISTRATIVE OFFICER'S REPORT - Lola Phillips, Deputy Administrative Officer

The Board was provided with an overview of the 2023 agency workplan.

## **HEALTH OFFICER REPORT** – Francisco Velázquez, MD, SM, FCAP, Health Officer

- Spokane County COVID-19 cases are 50.1 per 100,000. There have been no significant spikes in the community. Currently, the XBB.1.16 variant is being followed as it evades previous immunity and has resistance to antiviral medicines. The disease has a new symptom of pink eye. An additional bivalent vaccine is recommended.
- The CDC released a travel advisory for Guinea and Tanzania due to an outbreak of Marburg virus. Sacred Heart Medical Center has a special pathogens unit that could respond to this type of disease.
- There have been 47 states with outbreaks of Avian Influenza with about 59 million poultry affected. There is only one case of animal to human transmission in the U.S.
- The Food Safety program hosted temporary food establishment and donated food distributing organization seminars on April 13 and April 27, 2023.
- The Water Recreation program has permitted over 384 pools and spas. The program has developed a self-assessment checklist to help pool operators get ready for inspections.
- The SHAPE group brings together public health and healthcare to address health concerns that cannot be addressed alone. The group is currently working on Hepatitis C and Syphilis.
