• The Board was provided an overview of the Administrative Officer's first 30 days at the Health District.

# FINANCIAL REPORT – Kim Kramarz, Finance Director and Controller

• January expenses are at 7.8% of the budget as expected. Unassigned fund reserves are \$10 million, committed reserves are \$1.5 million and assigned reserves are at \$3.6 million. Unassigned reserves are at 18%. Once payments are received, the unassigned reserves will be at or above 20%. Total reserves are \$15 million.

## HEALTH OFFICER REPORT - Francisco Velázquez, MD, SM, FCAP, Health Officer

- There are 2,800 sites in the U.S. with PFAS contamination. In 2017, PFAS was identified in ground water on the West Plains in Spokane County. Measures are being taken to eliminate exposure.
- Spokane County has three confirmed cases of measles. All cases are in the same household and individuals
  were not immunized. SRHD has provided information to the press and providers and the response team has
  developed a form to track cases.
- Shigella Cases in Spokane County are decreasing.

- The Board received a report on SRHD fatality reviews from Mia Morton and Mary Malone, Keeping Children Safe Coordinators from the Health Living Program.

- The Board was provided with an update on liquid waste regulations by Jeffrey Harris, Environmental Health Specialist in the Liquid Waste Program.

- Commissioner Waldref thanked the agency for their work providing measles information.
