ADMINISTRATIVE OFFICER'S REPORT – Alicia M. Thompson, DrPH, LMSW, Administrative Officer

- Termaine Turntine, Jennifer Hansen and Christian Montiel were recognized for their work at the district.
- The Treatment Services program has a surplus of \$313,556 for the month of April. The program has been averaging 968 unique individuals served a month. The program is proposing to expand hours and hire a policy specialist position that will assist with the ability to expand hours.
- The Treatment Services electronic health record system vendor, SAMMS, was acquired by NetSmart. The contract will need to be reapproved by the board at the next meeting.

FINANCIAL REPORT – Kim Kramarz, Controller

- The 2024 budget totaled \$54,778,818 and ended at 97% of expenses and 101% of revenue, which created a surplus of \$2.185 million. The building reserve has been increased to \$1 million.
- The 2025 budget currently has a surplus of \$580,000 due to the receipt of Foundational Public Health Services funding. Reserves are at 26%.

HEALTH OFFICER REPORT – Francisco R. Velázquez, MD, SM, FCAP, Health Officer

- There are 880 cases of pertussis in the state of Washington. Spokane County has the most disease with 199 cases.
- Shigella disease has been contained within Spokane County.
- This flu season is considered severe in the nation. The CDC estimates there have been 46 81 million cases with 26,000-130,000 flu deaths.
- There have been 800 confirmed measles cases in the nation with 11% hospitalizations and two confirmed deaths. Twenty-five states have reported disease activity including Washington State.

LEGISLATIVE UPDATE – Lola Phillips, Deputy Administrative Officer

• The board received an update on Washington State legislative activity.
