ADMINISTRATIVE OFFICER'S REPORT – Alicia M. Thompson, DrPH, LMSW, Administrative Officer

- The proposed SRHD strategic plan will be brought forward to the Board in February. The Board will be invited to a special virtual staff forum on January 9 for an overview of the strategic plan.

FINANCIAL REPORT – Kim Kramarz, Controller and Finance Director

• The budget is 77% of expenses and 79% of revenue. The agency expected \$300,000 in interest this year but has received \$434,000 due to rate increases. Unassigned reserves are \$14 million (25% of budget) and total reserves are \$18.8 million.

HEALTH OFFICER REPORT – Francisco Velázquez, MD, SM, FCAP, Health Officer

- A pertussis outbreak was declared two weeks ago in Spokane County. There have been 1,500 cases statewide. Spokane County is in a high-density case rate area.
- Product recalls include cucumbers from Mexico, Kirkland organic eggs and McDonald eggs.
- All products in the listeria outbreak have been recalled and destroyed. The investigation has been closed.
- The 2024-2025 Community Health Needs Assessment will be reported to the Board in January.
- The Data Center has been working with community partners, Spokane Valley and City of Spokane to create a dashboard to better understand homelessness and programs that exist to provide support.

SITUATION

SRHD has needed to respond to multiple changes in the last 5 years. The challenges of three years of COVID added to changes in our working environment along with the customary uncertainties we all face daily have created an atmosphere where trust and good communication can be hard to find. The Arbinger Developing and Implementing an Outward Mindset training encourages a shift from a self- focused perspective to one where individuals actively consider the needs and perspectives of others.

This shift in mindset can significantly improve collaboration, employee engagement, retention, and overall performance by shifting the focus from individual needs to the needs of the team and organization. The shift in mindset leads to a more positive and productive work environment where everyone feels valued and accountable for collective success. The Outward Mindset teaching helps individuals to see others as people who matter, not just obstacles, fostering a culture of mutual support and shared goals.

BACKGROUND

SRHD was first introduced to Outward Mindset in 2018 as an all-staff training. While this training was well received, it was not adopted by the leadership of that time and the premise of the training was quickly forgotten. More recently in June of this year, the Executive Leadership Team reengaged with the Arbinger team for a two-day face to face training for The Outward Mindset, which included Outward Leadership. ELT wrapped up their training for the month of June by attending the Outward Inclusion training.

Paired with the training, ELT members have been collectively reading the book The Outward Mindset. While ELT members have been actively sharing the concepts and principles with their direct reports, and a video lesson is being shared at each Leadership Team Meeting, the dissemination of this information is too sporadic and is inconsistent in its messaging to create an impact on the SRHD culture.

ASSESSMENT

The Executive Leadership Team, after attending this training, realized that all leadership would benefit from receiving the training. With a stretch goal of all staff receiving the training in 2026.

RECOMMENDATION

SRHD recommends that the SRHD BOH approve contracting with the Arbinger Institute to allow 37 SRHD Leadership Team members to attend the training of the Outward Mindset Leadership Training and the Outward Inclusion training. The training includes lifetime access to the Digital workbook, forms, and training videos. SRHD recommends that the SRHD BOH approves \$69,543.00 funds to cover the full cost of this training at a breakdown cost of \$1,879.54 per staff. The funds to cover this training are from the Washington State Department of Health Workforce Development funds.

.CONTRACT FOR SERVICES

This Agreement is made and entered as of the _____ day of December, 2024, by and between Sayre Sayre & Fossum P.S., a Washington professional services corporation, hereinafter referred to as "Sayre Sayre & Fossum, P.S." and the Board of Health (the Board of Directors) of the Spokane Regional Health District, a Washington municipal corporation, hereinafter referred to as "SRHD" acting by and through its Chair, Amber Waldref.

WHEREAS, Sayre Sayre & Fossum. P.S. is engaged in the business of providing legal services; and

WHEREAS, SRHD has contracted with Sayre Sayre & Fossum, P.S. to provide legal services to SRHD as is described in more detail hereinbelow; and

WHEREAS, Sayre Sayre & Fossum, P.S. is willing to provide such services based upon the terms and conditions herein contained;

NOW, THEREFORE, for and in consideration of the recitations set forth above, the terms, conditions and covenants herein contained, and the mutual benefit derived here from, the parties do hereby, covenant and agree as follows:

1. <u>Term</u>.

The term of this agreement shall be for a period of twelve (12) months, commencing on January 1, 2025 and ending on December, 31, 2025, or until earlier terminated by either party in writing giving the other party sixty (60) days notice of such termination; subject, however, to extension by renewal or termination without notice as hereinafter provided.

2. Annual Review.

It is the desire of both parties to meet on an annual basis to discuss performance under this Agreement. To that end, during the month of October 2025, there shall be a meeting between the parties to discuss the level of satisfaction each party is experiencing in connection with the assignments and service provided during the past year, consider and discuss suggestions for improvement or change which would facilitate better use of attorney or SRHD management and staff time, and related topics. This process need not occur only in October 2025, and the parties anticipate that such review will be ongoing and encourage constructive interchange in that regard. As such, ongoing suggestions, complaints, improvements and utilization discussions are encouraged throughout the life of this Agreement in addition to the October 2025, meeting. In the event the parties have no issues to discuss in October 2025, SRHD may waive this requirement.

3. Nature of the Services.

Sayre Sayre & Fossum, P.S. agrees to provide any and all legal services requested by the Spokane Regional Health District Board of Health, by and through their employees or agents, and by the Administrator, as requested by the Administrator or SRHD during the period

of time covered by this Agreement, pursuant to the terms and conditions contained herein. The provision of these services shall be at the request of and in response to the needs of the SRHD. Services shall also be provided, upon request, to assist with the internal work of SRHD including, without limitation, such issues as personnel, contract drafting and review, litigation, attendance and participation at SRHD Board meetings, and any other need identified by SRHD. Sayre Sayre & Fossum, P.S. will also provide assistance, as requested by the SRHD, to interpret new and existing legislation, rules or regulations which impact the delivery of services by the SRHD.

4. Payment for Services.

As payment for services to be performed hereunder, SRHD shall pay Sayre Sayre & Fossum, P.S. according to the fee schedule set forth in Attachment "A". "Attorney", as defined herein, shall mean Michelle K. Fossum, or an admitted member of the Washington State Bar Association working for or associated with Michelle K. Fossum.

5. Payment Terms.

As of the date of commencement hereof, Sayre Sayre & Fossum, P.S. shall send a monthly statement to SRHD detailing the number of hours spent by each person on work requested by SRHD. Said statement shall detail the work for the preceding month and shall be due and owing on the date of receipt thereof. Payment shall be past due if not received within thirty (30) days hereafter. Any sum remaining due after thirty days shall be charged with a service charge equal to one percent (1%) on the unpaid balance until paid.

6. <u>Professional Liability Insurance</u>.

Sayre Sayre & Fossum, P.S. agrees to maintain professional liability insurance insuring itself, its agents and employees, with a reputable insurer and in the amount of at least one million dollars (\$1,000,000.00}. A copy of the certificate of insurance evidencing such coverage shall be provided to SRHD prior to the commencement of services and on a yearly basis thereafter. In the event Sayre Sayre & Fossum, P.S. elects to change insurers it may do so, provided its coverage limits are maintained at or in an amount greater than the limits currently held by Sayre Sayre & Fossum, P.S., and any subsequent insurance carrier selected shall be a reputable insurance company providing professional liability insurance to attorneys and similar organizations throughout the State of Washington or the United States of America.

7. <u>Cancellation and Renewal</u>.

This agreement is for a period of twelve (12) months, which is intended to permit the SRHD reasonable opportunities to review the performance of Sayre Sayre & Fossum, P.S. and, if desired (although not required), to periodically invite competing bids for legal services from time to time. This Agreement shall be for a period of twelve (12) months and, unless renewed as set forth herein below, at the end of the initial twelve month term, SRHD may (but is not required to) request proposals from other legal service providers by preparing a Request for Proposals ("RFP"), requesting proposals from individuals or law firms interested

in providing such services. Nothing herein shall prevent Sayre Sayre & Fossum, P.S. from responding to such an RFP with a proposal, and the SRHD shall be free to accept any such proposal, as the Board deems in the best interests of the SRHD.

Additionally, each party reserves the right to cancel this Agreement during the initial term hereof, or during any renewal period, by giving the other party notice of its intention to terminate this Agreement in writing not less than sixty {60} days prior to the termination date. There need be no stated reason for termination in such notice.

SRHD may renew this agreement for successive terms, to be agreed upon by the Parties, by giving written notice to Sayre Sayre & Fossum, P.S. thirty (30) days prior to the expiration of the term that it intends to renew the Agreement. In the event SRHD proposes to renew, and prior to acceptance, Sayre Sayre & Fossum, P.S. shall advise SRHD if the hourly rates contained herein shall be increased with the new term. If so, Sayre Sayre & Fossum, P.S. shall set such rates for the new term, and shall advise SRHD of the same. SRHD may then renew by written notice to Sayre Sayre & Fossum, P.S., or may request a meeting to negotiate the same, or may elect not to renew at that time.

8. <u>Default</u>.

In the event of default by either of the parties hereto, the non-defaulting party shall have all rights and remedies available by law.

9. Notices.

Any notice or communication transmitted by either party to the other party shall be sent by certified mail, return receipt requested, to the mailing address which is stated hereafter or to such other place as either party may hereafter designate to the other party.

10. Attorneys Fees.

In the event it shall be come necessary for either of the parties to obtain the services of an attorney to enforce the provisions hereof, the defaulting party shall pay the substantially prevailing party all damages and expenses resulting from the default, including all reasonable attorneys fees and all court costs, witness fees and other legal expenses incurred by the substantially prevailing party with or without the initiation of suit.

11. Venue and Applicable Law.

This Agreement is made in accordance with and shall be interpreted and governed by the laws of the State of Washington. If any action or other proceeding shall be brought on or in connection with this Agreement, the venue or such action shall be in Spokane County, Washington.

12. Waiver, Modification or Amendment.

No waiver, modification or amendment of any term or condition of this agreement shall be effective unless in writing, and no waiver or indulgence by either party of any deviation by the other party from full performance of this Agreement shall be a waiver of the right to subsequent or other full, strict and timely performance.

13. Merger Clause.

This Agreement represents the full and final purpose and Agreement of the parties and will not be qualified, modified or supplemented by course of dealing, usage of trade or course of performance. There are no verbal agreements which qualify, modify or supplement this Agreement.

14. Successors.

All rights and obligations to the parties hereunder shall be binding upon and inure to the benefit of their heirs, personal representatives, successors or assigns.

SITUATION

Exterior brickwork and mortar joints are failing and permitting moisture into the College Avenue building, with some bricks cracked or missing pieces. Each facade needs thorough cleaning and inspection, with precise replacement, tuckpointing, and repairs only as needed.

BACKGROUND

SRHD's brick facade is made up of standard face brick on vertical elevations and prefabricated thin brick placed on the numerous curved sections at each floor and between windows on the 1st, 2nd, and 3rd floor. Many areas of the brick mortar joint, control joints, and expansion joints are failing or have already failed, leading to further infiltration of moisture and air. Some bricks are chipped and worn away entirely and must be completely replaced.

ASSESSMENT

The College Avenue building has visible brick/masonry damage and is already growing exponentially which will cause the project cost to increase. Additionally, delaying this work could cause safety hazards around areas where loose brick and mortar could fall. The most cost-effective option is to move forward with restoration to correct damage that is already present and inhibit further degradation.

RECOMMENDATION

SRHD recommends that the SRHD BOH approve contracting with the Department of Energy Services (DES) to hire Millig Design for the repair, replacement, and restoration of the exterior brick on the College Avenue Building. Millig Design is currently our contractor through DES and is working with SRHD on the Building Energy Improvement project. SRHD recommends that the board approve working with Millig as part of that energy design project and approve the project proposal from Millig Design. Through DES, Millig's total project proposal cost is \$1,018,275.00. Funding for this project has been set aside in the Assigned Reserves.

SITUATION

SRHD was approved to contract with Kipu Health at the 10/31/2024 board of health meeting. When the contract was reviewed it was determined that it would not be in the best interest of SRHD to move forward with Kipu Health.

BACKGROUND

The contract we were asked to sign raised multiple concerns about exposure to SRHD. SRHD's procurement program created a list of these concerns, and we held an initial meeting with Kipu Health to discuss the concerns. The solution offered by Kipu Health did not address all our concerns and continued to leave SRHD with an unacceptable level of exposure. The contract was reviewed by SRHD's legal counsel, and they agreed that we should not move forward with Kipu Health.

In the Request for Proposals process, there was a second electronic health record (EHR) that was a close second in the scoring. This EHR, Substance Abuse Medication Management System (SAMMS) was asked to provide the RFP scoring team with a 2nd presentation on 1/15/2025 to ensure the system would meet the team's needs. A unanimous decision was made by the scoring team to discontinue negotiations with Kipu Health and to move forward with SAMMS.

RECOMMENDATION

We recommend the board approve TS to contract and onboard the new electronic health record (EHR) SAMMS. SAMMS demonstrated they will be able to meet TS needs. A request for proposal was issued on July 18, 2024. A total of nine (9) responses were received. After reviewing the proposals three vendors were selected to conduct a virtual demonstration. A team of 12 members from TS and administration participated throughout the RFP process. SAMMS had the second highest overall score and provided a comprehensive demonstration of their system, including patient safety and billing.

COST

The designated reserve for TS EHR will be used to cover the cost of the new system and maintaining the current system for one year. This includes the implementation costs and the annual costs of operation. The initial subscription will be for three years. The cost for the first year, which includes training, configuration, dashboard development, custom development, professional services and clearinghouse transactions is estimated to be \$76,076. The annual cost will be approximately \$34,776 per year.




Strategic Plan Survey Responses



Goal #1: Be visible and trusted in the community.


To what extent do you believe the proposed goal #1 effectively addresses the key challenges and opportunities facing our organization?






Goal #2: Be a model for evidence-based decision-making


To what extent do you believe proposed goal #3 effectively addresses the key challenges and opportunities facing our organization?



Current Situation in Washington State

There have been a total of 2040 confirmed and probable cases reported statewide during 2024 as of 11/28/2024, compared to 87 cases during the same period in 2023 (State Average 85 cases/Year). Multiple jurisdictions have reported increases.


Persons at high risk for pertussis:

- Infants <1 year old (who are at greatest risk for severe disease and death)
- Pregnant women in the last trimester (who may expose infants)
- Healthcare workers with direct patient contact (who may expose infants, pregnant women, or others who have contact with infants or pregnant women)
- Anyone who may expose infants < 1 year old or pregnant women (e.g., childbirth educators, childcare workers, members of a household with infants).



The overall year-to-date incidence rate is 25.9 pertussis cases per 100,000 Washington residents from weeks 1 through 52, with an incidence rate among infants under one year of age of 194.5 cases per 100,000 (see Table 1). Infants under one year of age are among the most vulnerable to severe pertussis disease.

Of the 172 infants who had pertussis so far in 2024: 149 were old enough to have received a dose of pertussis-containing vaccine, and 36 (21%) had received at least one dose.




Pertussis Incidence rates by County, 2024 Weeks 46-52

Epidemiological Curve for Pertussis Cases in Spokane County







Shigella Cases by Year Based on Onset of Symptoms











December 18, 2024-- A patient has been hospitalized with a severe case of avian influenza A(H5N1) virus ("H5N1 bird flu") infection in Louisiana. This marks the first instance of severe illness linked to the virus in the United States. The case was confirmed by the Centers for Disease Control and Prevention (CDC) on Friday, December 13. Since April 2024, there have been a total of 61 reported human cases of H5 bird flu reported in the United States.

January 6, 2025 -- CDC is saddened by Louisiana's report that a person previously hospitalized with severe avian influenza A(H5N1) illness ("H5N1 bird flu") has passed away. While tragic, a death from H5N1 bird flu in the United States is not unexpected because of the known potential for infection with these viruses to cause severe illness and death. As of January 6, 2025, there have been 66 confirmed human cases of H5N1 bird flu in the United States since 2024 and 67 since 2022. This is the first person in the United States who has died as a result of an H5 infection. Outside the United States, more than 950 cases of H5N1 bird flu have been reported to the World Health Organization [2]; about half of those have resulted in death.

ABSTRACT

BACKGROUND

CONCLUSIONS

In the cases identified to date, A(H5N1) viruses generally caused mild illness, mostly conjunctivitis, of short duration, predominantly in U.S. adults exposed to infected animals; most patients received prompt antiviral treatment. No evidence of human-to-human A(H5N1) transmission was identified. PPE use among occupationally exposed persons was suboptimal, which suggests that additional strategies are needed to reduce exposure risk. (Funded by the Centers for Disease Control and Prevention.)

Highly pathogenic avian influenza (HPAI) H5N9, Eurasian lineage goose/Guangdong clade 2.3.4.4b and HPAI H5N1 clade 2.3.4.4b were confirmed in a commercial duck premises in Merced County, CA. This is the first confirmed case of HPAI H5N9 in poultry in the United States. The USDA Animal and Plant Health Inspection Service (APHIS), in conjunction with State Animal Health and Wildlife Officials, are conducting comprehensive epidemiological investigations and enhanced surveillance in response to the HPAI related events.

Summary

The Centers for Disease Control and Prevention (CDC) is issuing this Health Alert Network (HAN) Health Advisory to clinicians and laboratories due to sporadic human infections with avian influenza A(H5N1) viruses amid high levels of seasonal influenza activity. CDC is recommending a shortened timeline for subtyping all influenza A specimens among hospitalized patients and increasing efforts at clinical laboratories to identify non-seasonal influenza. Clinicians and laboratorians are reminded to test for influenza in patients with suspected influenza and, going forward, to now expedite the subtyping of influenza A-positive specimens from hospitalized patients, particularly those in an intensive care unit (ICU). This approach can help prevent delays in identifying human infections with avian influenza A(H5N1) viruses, supporting optimal patient care and timely infection control and case investigation.



Recommendations for Testing of Hospitalized Patients

In addition to jurisdiction-specific instructions for sending specimens for subtyping, CDC now recommends that all influenza A positive respiratory specimens from hospitalized patients, especially from those in an ICU, be subtyped for seasonal influenza A viruses [A(H1) and A(H3)] as soon as possible following admission—ideally within 24 hours—to support optimal patient care and <u>proper infection prevention and control</u> measures and to facilitate rapid <u>public health</u> investigation and action.

Recommendations for Clinicians

- When collecting a thorough exposure history from a patient with suspected or confirmed influenza who is
 hospitalized, ask about potential exposure to wild and domestic animals, including pets (e.g., cats), and animal
 products (e.g., poultry, dairy cows, raw cow milk and raw cow milk products, raw meat-based pet food), or recent
 close contact with a symptomatic person with a probable or confirmed case of A(H5).
- Implement appropriate infection control measures when influenza is suspected.
 - If avian influenza A(H5) virus infection is suspected, probable, or confirmed in a hospitalized patient, place the
 patient in an airborne infection isolation room with negative pressure with implementation by caregivers of
 <u>standard, contact, and airborne precautions</u> with eye protection (goggles or face shield).
- Test for seasonal influenza A in hospitalized patients with suspected seasonal influenza or novel influenza A virus
 infection such as avian influenza A virus infection, using whatever diagnostic test is most readily available for initial
 diagnosis.
 - If the initial diagnostic test does not subtype [e.g., identify A(H1) and A(H3)], order an influenza A subtyping
 diagnostic test within 24 hours of hospital admission for patients who tested positive for influenza A.
 - Subtyping should be performed with assays available to the testing laboratory, as follows:
 - Subtyping tests should be performed in the hospital clinical laboratory, if available.
 - Alternatively, specimens should be sent to a commercial clinical laboratory.
 - If influenza A virus subtyping is not available through one of these routes, arrangements can made for influenza A virus-positive specimens to be subtyped at a public health laboratory.
- Any hospitalized patients, especially those in an ICU, with suspected seasonal influenza or avian influenza A(H5) should be started on <u>antiviral treatment</u> with oseltamivir as soon as possible without waiting for the results of influenza testing.
 - Consider combination antiviral treatment for hospitalized patients with avian influenza A(H5) virus infection.
- Notify the health department promptly if avian influenza A(H5N1) virus infection is suspected, probable, or confirmed in a hospitalized patient.
- Questions about appropriate clinical management or testing of hospitalized patients with novel influenza A virus infection [e.g., A(H5)], including about combination antiviral treatment dosing or testing for antiviral resistance, can be directed to the CDC Influenza Division for consultation with a medical officer via the CDC Emergency Operations Center at 770-488-7100.





Community Collaborations

The PHEPR team has been continuing to work on rebuilding our internal infrastructure after the pandemic response. Two priority areas were our Continuity of Operations Plan and our internal Incident Management Team.

The Continuity of Operations Plan needed updates based on a lot of lessons learned during the pandemic and how our staff can function in hybrid situations

- Each program has completed the worksheets that helps them identify priorities and timelines
- Updated the Delegation of Authority for each Division Director
- Identified new COOP leads for each division and they have received training

SRHD's internal Incident Management Team needed to be re-built based on a high level of staff turnover during the pandemic

- We've implemented a requirement for all new staff to take a basic course in learning our role in a public health response
- All managers have taken the basic course plus one additional course in response
- All newly identified Incident Management team members have taken advanced courses in response.
- In February they begin the next level of training which pertains specifically to how SRHD's plans are invoked and their individual roles


