# HEALTH OFFICER REPORT – Francisco Velázquez, MD, SM, FCAP, Interim Health Officer

- The Board received an update on the COVID-19 pandemic response.
- Between Easter and spring break there was uptick in COVID-19 cases in school students between 13 and 17 years of age. Most cases were traced back to sports events where guidance was not followed. Most schools have begun COVID-19 testing for students in sports and students in special education.
- The B.1.1.7 COVID-19 variant will most likely surpass any variants in Washington State. There are currently 18 cases of the B.1.429, four cases of the B.1.427, eleven cases of the B.1.1.7 and six of the P.1 identified in Spokane County.
- There have been 217 COVID-19 vaccine breakthrough cases in Washington State. There have been 23 confirmed, seven probable and ten cases that are being investigated in Spokane County.
- As of April 28, 2021, there have been four confirmed cases of salmonella typhi (Typhoid Fever) in Spokane County.
